### 2.6.2 Attainment of programme outcomes and course outcomes are evaluated by the institution.

The academic learning value is determined by the Programme Outcomes (POs) and Course Outcomes (COs) of every Programme and Course that the Institute delivers.

The institute created its POs and COs with an idealistic viewpoint in order to be in line with the goals of each programme as well as the institution's vision, purpose, and quality policy.


The essential knowledge that students must gain and the expected degree of learning at the conclusion of the course are concisely described in the course outcomes. The university determines the requirements of students' professional potential and provides a selection of curricula that are geared to meet those opportunities.

Improving students' knowledge and skills is the primary objective of the course and programme outcomes as they are necessary for them to reach their full potential and become the people they want to be. Furthermore, attention is put on students' holistic development via the teaching of morals and values and the development of their interpersonal and communication skills through learning outcomes. The POs, COs, and PSOs have consulted with subject matter experts and are prepared for all UG and PG courses. The whole faculty got together for brainstorming meetings in order to compose them. Lesson plans, which include the course goals, course outcomes, teaching materials, and total number of teaching hours, are produced at the beginning of the academic year. Before being posted on the notice boards, all course COs are approved by the IQAC. POs and COs are important topics of debate at every IQAC meeting. To make the college's perspectives apparent, the vision, purpose, values, and objectives are all prominently displayed at the entrance.

The vision, purpose, programme outcomes (POs), programme specific outcomes (PSOs), and course outcomes (COs) for each of the institute's programmes are listed, uploaded, and distributed to all college personnel and students. Recently recruited staff members get a briefing about the course and programme objectives. Following the assignment of the required courses, they get an explanation of POs, PSOs, and COs. At the beginning of each semester, each faculty member provides an outline of the course content and expectations to the students. The numerous laboratories, libraries, and offices within the departments all have copies of the syllabus on file. They are accessible to all parties, including the staff and students. Parents and kids learn about POs, PSOs, and COs at the beginning of the school year during the Orientation Programme.
