#### **WHEREAS**

NOW, THEREFORE, in consideration of the mutual promises as set forth in this MOU, the parties agree as follows:

#### 1. DATE OF COMMENCEMENT AND TERM OF AGREEMENT:

This MOU shall be effective from 1<sup>st</sup> December 2023 (hereinafter referred to as "date of commencement") and shall be valid, unless terminated, for a duration of 5 Years from the date of the commencement of this MOU.





#### 2. RIGHTS AND OBLIGATIONS:

The mutual Rights and Obligations of Humano Forte and College shall be as set forth hereinbelow:

- 2.9 Humano Forte shall provide mentoring and counselling sessions to students on career related topics.
- 2.10 The collection of fees from students shall be the sole responsibility of Humano Forte.
- 2.11 College shall provide a list of students enrolled in various courses of the institution.
- 2.12 College shall coordinate with Humano Forte for the placement assistance of students.





- 2.13 College shall help students to register themselves on the website or any other digital platform developed by Humano Forte.
- 2.14 College shall extend necessary support, in the event, a guest lecture by an industry expert in the Institute premises is organized by Humano Forte.
- 2.15 College shall provide infrastructure to Humano Forte like classrooms, seminar halls, audiovisual aids, practical labs, instruments and equipment for the smooth conduct of the training program without any cost.
- 2.16 College shall perform testing and certification of students in accordance with external certification program, if any required by the industries.
- 2.17 Both the Parties hereto shall coordinate to obtain all approvals, consents, permissions, and licenses of whatsoever nature required for offering placements to students.

#### 3. CONSIDERATION (FINANCIALS):

#### 5. FORCE MAJEURE:

- 5.1 Both the parties hereto shall be entitled to suspend or excuse performance of its respective obligations under this MOU to the extent that such performance is impeded by an event of Force Majeure.
- 5.2 Force Majeure means and includes but not limited to situations which are beyond the control of person, natural disasters like floods, earthquakes, cyclones and weather disturbances, other covered events may include war, terrorist attacks, fire, civil riots, disease or medical epidemics or medical pandemics and curtailment of transportation facilities.
- 5.3 In the event of Force Majeure if any of the party wants to rely on Force Majeure clause to absolve itself of any liability then it shall invoke the clause of Force Majeure by giving written intimation of same to other party within 30 days of the occurrence of such event.

#### 7. SEVERABILITY:

#### 8. RENEWAL CLAUSE:

This MOU, unless terminated, may be extended for 5 years and mutual discussion and on such terms and conditions as may be agreed by mutual consent of the parties. The intimation of renewal of this MOU shall be in the form of written notice sent by one party of this MOU to the other party 90 days in advance to





expiry of this MOU.

#### 9. INTELLECTUAL PROPERTY RIGHTS:

#### 10. GOVERNING LAW & ARBITRATION


#### 11. TERMINATION:
